Minutes of the City Council Meeting
June 3, 2014

The meeting was called to order at 7:00 PM by Mayor Paulson

Public Comments: Ken Larsen voiced concern about GLO-PAC involvement in city business. Lucie Swarm read a statement of her concerns regarding the part-time CA position. Andrea Larsen voiced concern with Mayor's comments in past CC meetings, and the behavior of a few citizens towards council after last CC meeting. Gary Reese thanked the Public Works employees for the hard work they have done. He also voiced concern about public comments made at the May 27, 2014. Judith Rennert voiced concern regarding behavior from public towards councilor after CC meeting on May 27, 2014. Maggie Osgood commented she believes Ordinance 242 should remain. Dave Rommel voiced concern with spending city money doing non-city work. He feels the Ordinance 242 should be repealed and is concerned with contracting out public works duties. Bob Burr voiced concern about a part-time CA position. Jerry Bjornstad voiced concern on repealing the Ordinance 242 and the negative energy being displayed.

Mr. Laroque gave a power point presentation to the Council and audience. Questions from Council were answered by Mr. Laroque and Mr. Helliwell. Council also had questions for City Attorney, Mr. Mecham.
