Lowell is on the *move...*

In a momentous 5-0 vote at the August 28, board meeting, the Lowell School Board approved Resolution 2017-18-1, allowing the district to seek voter approval to issue bonds to finance capital costs. Should the bonds be approved, the State will provide a matching guaranteed \$3 million grant, with the possibility of an additional \$1 million grant towards the cost of the projects!

If the voters choose not to approve the bond, these State funds will be given to another District. Additionally, the District received a \$1 million State seismic grant to help defray costs, for a total of \$4 million in State grants. This results in receiving \$2 of value for the cost of \$1 of local funding, if the bond is approved. Proceeds would be used to:

- Modernize and renovate the interior of both school buildings, including upgraded mechanical, plumbing, lighting, and technology systems;
- Make safety and security upgrades in both school buildings, including secured entrances to the schools; and,
- Build a new gym and wrestling room and convert the existing high school gym into a multipurpose center/performing arts venue.

This is a tremendous opportunity for the Lowell School District and the Lowell/Fall Creek Community!

The School Board has taken an assertive approach to bring funds to our community which are sorely needed. Our future is our youth and this is our opportunity to make significant improvements to the two schools for both our students and the community as a whole.

The Lowell School District Proposed Bond proceeds would:

- Modernize and renovate the interior of both school buildings, including upgraded mechanical, plumbing, lighting, and technology systems;
- Make safety and security upgrades in both school buildings; and,
- Build a new gym and wrestling room and convert the existing high school gym into a multipurpose center/performing arts venue,

The Lowell School District tax rate presently ranks 19th out of 20 comparison districts. If a local \$4 million bond is approved it will increase the local tax rate by \$1.06 per \$1,000 assessed value, and will be matched by \$4 million of State Matching Funds. The bond would increase the total tax rate from \$5.0409 to \$6.1009, which will place Lowell 13th of the 20 comparable districts. With the passage of the bond, and with the matching \$4 million of funding from the State, the District will be able to double the classroom capacity at Lundy Elementary and Lowell high School without the need to return to the voters.

Back to School Means Sharing the Road

School days can bring congestion, even in the small town of Lowell: buses are picking up children, kids on bikes are hurrying to get to school, parents are trying to drop their kids off before work. It's never more important for drivers to slow down and pay attention than when kids are present – especially before and after school. The National Safety Council provides the following guidance to help keep kids safe this school year:

If You're Dropping Off

Schools often have very specific drop-off procedures for the school year. Make sure you know them for the safety of all kids. According to the National Safe Routes to School program, more children are hit by cars near schools than at any other location. The following apply to all school zones:

- Don't double park; it blocks visibility for other children and vehicles
- Don't load or unload children across the street from the school
- Carpool to reduce the number of vehicles at the school

Sharing the Road with Young Pedestrians

According to research by the National Safety Council, most of the children who lose their lives in bus-related incidents are 4 to 7 years old. They are hit by the bus, or by a motorist illegally passing a stopped bus, while walking to school. A few precautions go a long way toward keeping children safe:

- Don't block the crosswalk when stopped at a red light or waiting to make a turn, forcing pedestrians to go around you, as this could put them in the path of traffic
- Stop and yield to pedestrians crossing the crosswalk or intersection
- Always stop for a school patrol officer or crossing guard holding up a stop sign
- Take extra care to look out for children in school zones, near playgrounds and parks, and in all residential areas
- Don't honk or rev your engine to scare a pedestrian
- Never pass a vehicle stopped for pedestrians
- Always use extreme caution to avoid striking pedestrians wherever they may be, no matter who has the right of way

Sharing the Road with School Buses

If you're driving behind a bus, allow a greater following distance than if you were driving behind a car. It will give you more time to stop once the yellow lights start flashing. It is illegal in all 50 states to pass a school bus that is stopped to load or unload children.

- Never pass a bus from behind or from either direction if you're on an undivided road if it is stopped to load or unload children
- If the yellow or red lights are flashing and the stop arm is extended, traffic must stop
- The area 10 feet around a school bus is the most dangerous for children; stop far enough back to allow them space to safely enter and exit the bus
- Be alert; children often are unpredictable, and tend to ignore hazards and take risks

By exercising a little extra care and caution, drivers and pedestrians can co-exist safely in school zones.

Jones Fire Update

On Thursday, August 10, a fire started from a lightning strike approximately ten miles northeast of Lowell in the Willamette National Forest. As of August 25, the fire covered 5,579 acres with a mobilized response team of 722 personnel. The fire has resulted in the closure of campgrounds in the vicinity, however there have been no evacuations or structures destroyed. Lowell City Council Actions

This report of actions taken by the Lowell City Council is a regular feature of this newsletter and is provided to inform citizens of recent decisions made by the council.

At the August 1st study session, the following topics were addressed:

- Approved Resolution 682—Establishing a Temporary Greywater Disposal Fee in the amount of \$0.15 per gallon.

Motions were approved 5-0. In support: Bennett, Burford, Harris, Angelini and Osgood.

Training Update

The past few months your firefighters have been busy training, working hard and preparing to help the community in its time of need. Since January our firefighters have earned certifications ranging from Hazmat Incident Commander to Fire Apparatus Operator Equipped with a Fire Pump.

In June Lowell hosted a Multi-District Water Supply Drill. Our neighboring districts of Dexter, Pleasant Hill and Goshen participated. This drill went very well as each department found ways to work better together. This type of ongoing training allowed us to prepare to fight fires outside the hydranted areas of our district also.

In August five new firefighters began their initial training with the fire district. This initial training is designed to prepare new personnel for a career in the fire service. Recruits will be in academy learning about various subjects ranging from how to extinguish fires to search and rescue. Following academy, the recruits will begin pulling duty shifts and running calls with the district. Academy is scheduled to be completed on October 1st.

The district will also have the opportunity to train with the Department of Public Safety Standards and Trainings Firefighter Self-rescue prop in August and the Flammable Liquids and Gases prop in October. These training sessions allow District Firefighters the opportunity to train on props that the district normally does not have access to.

Meet Your Firefighters

This month we are introducing Training Officer Lloyd Hall. Lloyd began his firefighting career here in Lowell in 2008. Lloyd has risen through the ranks from intern firefighter to Lieutenant and in 2016 Lloyd accepted the position as the full-time training officer.

Lloyd served as a resident firefighter for five years from 2009 to 2014. During this time he earned his Firefighter 1, Firefighter 2, and Engineer certifications. Lloyd attended school at Lane Community College attaining his EMT certification. In 2016 he returned to Lane to acquire his EMT-Intermediate certification so he could better serve the community. He has also received a few awards over his career with the fire district, the highlight was being voted volunteer of the year three times by his fellow firefighters.

In the summer of 2016 Lloyd bought a house in Lowell. He loves living in this area and frequently goes to the lake or Paul Fischer Park with his family. Lloyd hopes he can be a member of this community for many years to come.



Fire Support Causes Temporary Recreation Area Closures

Three recreation areas at Dexter and Lookout Point Reservoirs have been closed to the public to support firefighting efforts at the Jones Fire, located in the Little Fall Creek watershed in the Willamette National Forest.

The following areas are closed for life support, storage and equipment use:

- Lowell State Park at the north shore of Dexter Reservoir
- Meridian Park at Lookout Point Reservoir near the north end of the dam
- Lookout Point Dam Overlook Area at the north end of the dam

The closures are expected to last about two weeks, but may vary. Lowell State Park will be re-opened to the public before the drag boat races scheduled for September 16-17.
